

CURRICULUM VITAE

Assunta Brizio was born in Naples on 8.1.1950 and is resident in Cagliari, via Tuveri no. 6, post code 09129.

After attaining a secondary school diploma in classical studies she graduated in law at Federico II university of Naples in November 1972 with marks 110/110 summa cum laude, with a dissertation in civil law entitled: “l’errore sulla qualità essenziale della cosa” (error on the essential quality of things).

Following a public examination for graduates she was hired by INAIL (national institute for insurance against industrial injuries), Rome general management office – personnel service in June 1974 with the role of “advisor”.

After taking her jurisprudence examination, in November 1976 she started her magistrate internship with the title of “recorder/trainee judge” at the offices in Rome; she was assigned her jurisdictional functions at the Cagliari district court – labour section, where she worked until 1982; from 1982 to 1986 she performed her functions at the Cagliari criminal district, settling in Cagliari definitively in terms of professional and private life.

To expand her professional background, she asked and obtained to be transferred to the court of Cagliari, where she worked at the criminal section first and the civil section afterwards, until December 1992.

In January 1993 she was transferred, upon her request, to the Cagliari Court of Appeal where she worked in the civil and juvenile section until 2005, at times also serving for the criminal crown court as associate advisor.

From December 2005 to 1 October 2010 (when she became entitled to an old-age pension) she served as President of the II civil section of the Court of Cagliari, a section specialised in “obligations and contracts” and “rights in rem”, directing and coordinating the activity of 12 magistrates and cooperating with the President of the court in managing and organising the entire section.

As rapporteur she also took part in many meetings organised to study legal matters at national and regional level.

Since she retired, due to her extensive experience she still receives assignments in various arbitrations, as president of the board or as a single arbitrator.

Due to her new professional commitments, she resigned from the office as President of the section of the Cagliari regional tax commission, a position she had covered since 1996.

She was twice a member of the commission examining attorneys' appointments.

For four years she was a member of the judicial council at the Cagliari Court of Appeal, a self-government board of the judiciary.

She also chaired some commissions such as the one to assign council houses at the municipality of Settimo San Pietro.

She has taken part in and has sometimes chaired the Boards for the legality control of electoral operations both municipally and regionally.

At the meeting of the Board of Directors of the company listed in the stock exchange TISCALI spa of 28 August 2012 she was co-opted as independent director of the same BoD and as member of the Risk control committee and the Appointment and remuneration committee and will remain in office until the next company meeting.

She first joined the Board of Directors and Risk control committee in 13 November 2012.
